F. REGINALD ATWELL Jr., was born in the Republic of Panama, a son of the late Rev. F. Reginald Atwell, who at the time of his demise was Dean of St. Paul's Episcopal Church. Mr. Atwell Jr., received his education under the late Prof. Barton and following his graduation obtained employment with Mr. Harry C. Nicholls, representative for the distribution of Dodge vehicles. After Mr. Nicholls retired, the Dodge Agency was acquired by Colon Motors and Mr. Atwell was immediately

contracted to supervise the Sales Department and he is still in their service.

Mr. Atwell in his youth was one of the principal Acolytes of St. Paul's Church.



ALLAN K. SMITH was born in Gorgona (La Vieja), Republic of Panama. He had his Primary education there under the tutorship of Teacher Johnson, who later became Principal of Local Rate Schools in the Canal Zone. Mr. Smith, following his primary studies went to Kingston, Jamaica, where he completed Secondary and High School training, returning to Panama in 1919. Upon his return he obtained employment with Seymour

Agency, specializing in Insurance of all kinds. He is now separated from Seymour Agency and is an Independent Insurance Broker.

He is proud of the fact that, at the invitation of Mr. Albert A. Steer, he was active in the Social which preceded the formation and foundation of Court Panama, No. 10,026, of the Ancient Order of Foresters. Incidentally, Court Panama is the first mixed Court in the Republic.

Mr. Smith was Treasurer for many years, then elected to Chief Ranger and is presently Secretary. Following his tenure as Chief Ranger, he was conferred the Sublime Degree.

HERIBERTO ANTONIO SOLEY was born in Panama City. His parents were Mr. & Mrs. Solomon Samuel Soley, Jamaicans who migrated to Panama shortly after obtaining its Independence.

He is also the grandson of James A. Polack, Founder of Court Brock, No. 6725, of the Ancient Order of Foresters, one of the first of such Societies established in the Republic of Panama.

He obtained his education through the tutorship of teachers Thomas and Yearwood, West Indian Pedagogos who taught many off-spring of West Indians who migrated to the Isthmus. The Honoree, after terminating his studies started working in the automobile business and up to the present time is one of the out-standing Sales-Agent in the Colpan Motors, distributors of the Ford Auto Lines. He was also connected to many Clubs and Societies, of which he attained the highest positions.

Known as one of the Foundation Members of Court Panama, No. 10,026 A.O.F., he devoted his time with much zeal the planning of social to bring about the inauguration of the Court on the 29th of Sept. 1934. From thence he served all the Minor Offices in such a satisfactory manner that in a short span of time, was honored with being selected to be given the highest office of Past Chief Ranger.

Bro. Soley was the Treasurer of our Court for many years, office which he relinquished in order to devote more time to other activities in behalf of the Court.

On this occasion of our Fortieth Anniversary, we take much pleasure in honoring one more of our members who has devoted forty years of his life in the interest of the Court and Order.

A BRIEF HSITORY OF COURT PANAMA No. 10,026, A.O.F.

Early in the year 1934, Bro. Albert A. Steer, (R.I.P.) a past Chief Ranger of Court Atlantic, No. 9914, but at that time a resident of Panama, conceived the idea of creating a Mixed Court of Foresters on the Isthmus, as there was none at that time. With the able assistance of Bro. Auguste Ceville (R.I.P.) a Sub-Chief Ranger of Ct. Atlantic, and Bro. Ernest Robertson, a Sub-Chief Ranger of Ct. Pacific, a number of friends were invited to form a Social, and among these, the following are outstanding: Bro. Allan K. Smith, Bro. F. Reginald Atwell Jr., Bro. Victor A. Charles (R.I.P.), Bro. Lionel F. Grant, Bro. Heriberto A. Soley, Bro. Henry R. George, (R.I.P.) Bro. Wilton Ford, Sis. Mae Chen, Sis. Sadie Steer and Sis. Alice Myers. Others came in and at the time of our inauguration our membership totalled 35.

A Dispensation was applied for, and granted by The Executive Council and Court Panama, No. 10,026, of the Ancient Order of Foresters, the first Mixed Court in the Republic, was inaugurated on the 29th of September 1934.

When it became know that Court Panama was in existence, the Sister Courts on the Pacific Side protested to the High Court and had it not been for the integrity and intuition of Bro. F. R. Atwell, Jr., who pointed out certain legal aspects concerning our existence, perhaps Court Panama may not have existed. Be that as it may, and by maneuvering our place of meeting, the protesting Courts finally desisted in their antagonism and eventually embraced us with open arms. It must be recorded here that Court Atlantic, No. 9914 assisted us in every possible way and thereby paved the way for the Sister Courts on both sides of the Isthmus to finally accept us as Foresters.

Within a year of our opening our membership rose to 100. However, as time went by, many members migrated to the U.S.A. others retired and returned to their native homes, and sad to say, many have passed on to a better world. At the present time we have an active membership of 22 and with the Help of God we anticipate a substantial increase in our membership.
